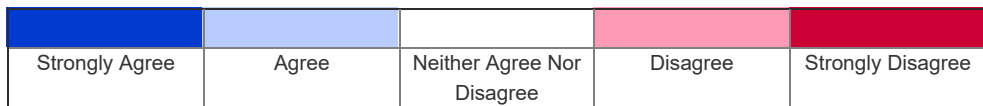

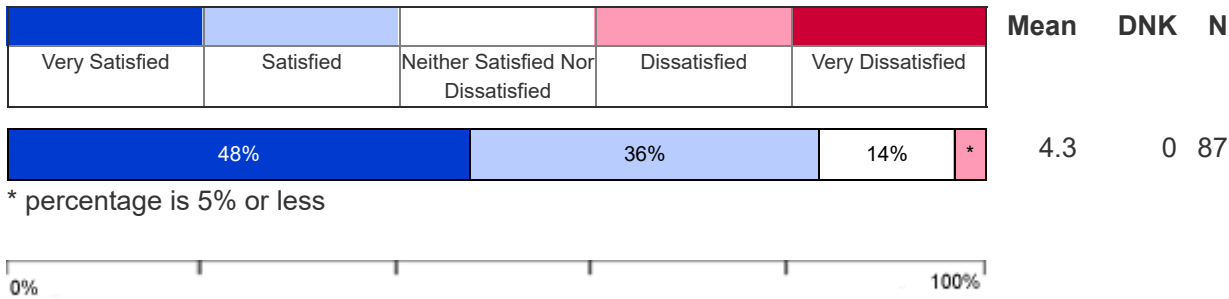

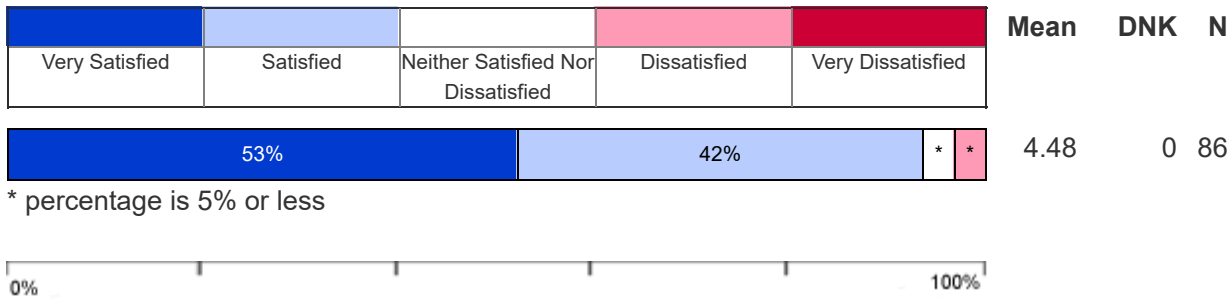

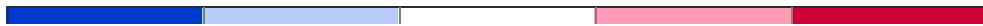

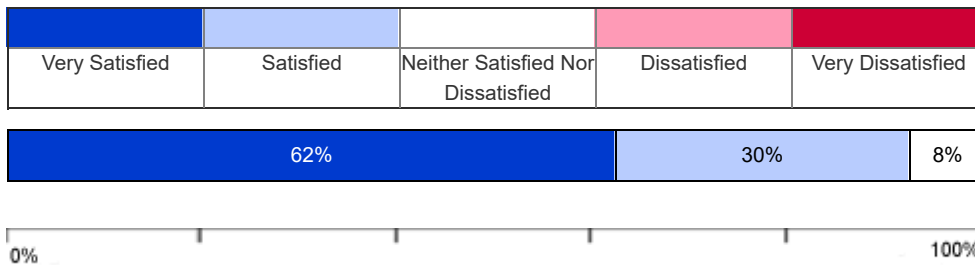

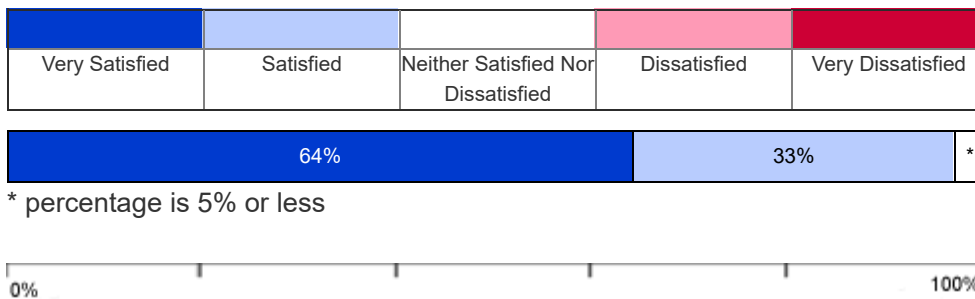
75. Considering everything, how satisfied are you with your job?
